These releases are designed to inform competitors of changes or information that may not have been available or clarified at the time of releasing the Supplementary Regulations.

### **Ambulance Levy:**

The ambulance levy is **not** applicable to Minders in this event. Minders must be entered and registered before the event. It is compulsory for all competitors to pay the levy.

### **Open Women Class:**

We made an announcement earlier in the month in regard to the setting of the open women's class. In order to raise the profile of women competing in trials it has been agreed to set the sections in the following format:

- **6 x C grade lines**
- **6 x C+ Lines**
- **3 x B Grade Lines**

We are trying to encourage our younger women to challenge themselves but still offer our experienced riders the challenge they require.

### **Pre Solo Class:**

This class has been allowed by MA for ages 22-35 years old and designed to encourage riders of B grade or above to improve with a goal to reaching Masters or Open solo.

While it is included in the event it is a **NON** Championship class, however will be awarded trophies.

### **Teams Event Scoring:**

The teams event will be scored in the following method with the lowest score being the winner.

Riders will attract a points score equivalent to their finishing position, 1st place = 1 point, 2nd place = 2 points etc. and the 4 nominated riders scores will be totalled.

Example:

Rider A: Class Finish Position 1st = 1 Point

Rider B: Class Finish Position 5th = 5 Points

Rider C: Class Finish Position 3th = 3Points

Rider D: Class Finish Position 15th = 15 Points

**Team Score is: 24 Points**

4 Riders will constitute 1 Team only. Individuals are still able to be selected in other teams up to a maximum of 3 as per the conditions mention on the nomination form. It is selected by the organisers as "first in" and any subsequent entries will have to change a minimum of 1 rider. You will be notified if a change has to happen.

*Note: You must sign on before you ride for insurance purposes. Someone will be available and it will be signed as a U turn is required on the Hwy to access the property.*
